Without mental health...there can be no true physical health.

The mental health crisis is a global problem for humanity with major impact on our families locally.

### Globally.

- Depression is the # 2 cause of both disability and disease worldwide.
- 25% of all people suffer from mental disorders (1 in 4).
- 350,000,000 people are clinically depressed.
- More than 1,000,000 people take their life each year.
- 3,000 commit suicide on a daily basis.





### Youth.

- #2 leading cause of death among 10-24 year olds is suicide (just replaced homicide in June 2016).
- The average delay between onset and intervention is nearly 10 years.
- 50% of long-term mental illnesses are present by the age 14.
- 1 out of 5 teens live with a mental condition.
- 75% of long-term mental illnesses are present by age 24.
- 70% of youth in state and local juvenile justice systems have a mental illness.
- 90% of those who died by suicide had one or more underlying mental illness(es).

- North Fulton is not immune to the global mental health crisis.
- Suicide and Opioid Overdose are the #1 & #2 epidemics in our homes, schools, and neighborhoods...and the leading concerns of our community leaders.
